



## Terms & Conditions for Hari Raya Aidilfitri 2023 Giveaway (“The Giveaway”)

The Giveaway runs from 04 April 2023, 0000 hrs to 17 April 2023, 2359 hrs.

- 1) The Giveaway is open to all residents in Singapore who are aged 18 years old and above as of the date of participation in the Giveaway. Participants below 18 years old shall be required to obtain the consent of his/her parent or legal guardian.
- 2) To be eligible for the Giveaway, you must do the following:
